

With reference to the above, the St. Pauls school was inspected by the Dy. District Education Officer (Sh. N. S. Jhala) and according to his report and remarks put forth on the attached prescribed forms, the institution is running from 1966 and the tenure of last recognition was extended vide your good honour 30th June, 76. The conditions of temporary recognition laid down previously in letter no. DDE-UB/Recog/43 dated 28.6.66 have completely been fulfilled by the school authorities, but still some new conditions have been added viz,

1. The fees should be charged from students according to Govt scales.
2. All accounts registers Cash Books, Stock Registers, Ledgers and P.F. accounts should be prepared in the prescribed forms and maintained.
3. The managing body should be in accordance with this office No. IS-KT/74-75/1959-99 dated 17th June, 74

In view of the facts that the school is imparting Education up to the Higher Secondary stage in English medium and has got approval from the Central Board of Secondary Education, New Delhi, hence there is no harm if permanent recognition is granted to the above institution after satisfying the above conditions.
